



## CHM principle status quo (2) [1994~2019]

[2019]

#### International Tribunal for the Law of the Sea (ITLOS)

"125. ...sponsoring States (as well as the Authority) "shall apply a precautionary approach, as reflected in Principle 15 of the Rio Declaration" in order "to ensure effective protection for the marine environment from harmful effects which may arise from activities in the Area".

. . .

127. The provisions of the aforementioned Regulations transform this non-binding statement of the precautionary approach in the Rio Declaration into a binding obligation. The implementation of the precautionary approach as defined in these Regulations is one of the obligations of sponsoring States." [6]

#### [2020]

#### **Inter-American Court of Human Rights**

"207. Regarding the right to a healthy environment, ... States not only have the obligation to respect this but also the obligation established ... to ensure it, and one of the ways of complying with this is by preventing violations...

208. Nevertheless, specifically with regard to the environment, it should be stressed that the principle of prevention of environmental harm forms part of customary international law and entails the State obligation to implement the necessary measures ex ante damage is caused to the environment, taking into account that, owing to its particularities, after the damage has occurred, it will frequently not be possible to restore the previous situation. Based on the duty of prevention, ... 'States are bound to use all the means at their disposal to avoid activities under its jurisdiction causing significant harm to the environment.' This obligation must be fulfilled in keeping with the standard of due diligence, which must be appropriate and proportionate to the level of risk of environmental harm..." [7]


